- Completed Application: All sections must be completed and signed.

- Personal Statement: No longer than ONE page. Write a short biographical sketch. How would the legislative office benefit from having you in the office? What interest, experience, or background do you have in public policy or government affairs (school, work, volunteerism, etc.)?
- College Transcripts: Copies are acceptable. Your name must appear on the document. Official transcripts indicating expected graduation date and degree will be required of all applicants selected for the program.

Eligibility:

- Must have a 3.0 overall GPA or higher;
- Must be at least a Junior in standing (60 units completed) OR
- Must be a Graduate student in standing.
