ELIGIBILITY

- Must have a 3.0 overall GPA or higher
- Must be at least a Junior in standing (60 units) if enrolled in a University OR must be at least a Sophomore (30 units) in standing if enrolled in a Community College OR enrolled in a Graduate program during the semester of the internship.
- Must be able to work at least 10-15 hours per week during the Fall (hours requirement is 150 hours total) for local placement

APPLICATION REQUIREMENTS

- **Completed Application:** All sections must be completed and signed.
- **Current Resume**
- **Personal Statement:** No longer than ONE page with your name on the document. Write a short biographical sketch. Explain how a legislative office would benefit from having you in the office. What interest, experience, or background do you have in public policy or government affairs (school, work, volunteerism, etc.)? When and how have you exhibited leadership? What is your long-term commitment to making the Valley a better place? How do you plan to do it?
- **College Transcripts:** Copies of unofficial transcripts are acceptable. Please submit as a PDF. Your name and total GPA **must** appear on the document.
